### **CHAIRPERSON'S STATEMENT**

On the morning of Monday, 26 August, two Macedonian police officers were killed in a drive-by shooting, near the town of Gostivar, in the former Yugoslav Republic of Macedonia. I would like to take the floor to transmit our condolences to the families of the victims.

We condemn in the strongest terms this cowardly act of violence as well as any action that would aim at undermining the stability in the country and the implementation of the Framework Agreement. The perpetrators of this criminal act should be prosecuted to the full extent of the law and brought to justice. The OSCE Spillover Monitor Mission to Skopje is monitoring the situation and has offered its support to the Government in the investigation of the case.

I believe I am reflecting the opinions around this table by calling on all the political leaders in the country to ensure that the election campaign and the elections themselves are free, fair and peaceful and that all leaders will refrain from any form of intimidation or inflammatory rhetoric. As Foreign Minister Čašule said at this Permanent Council, on 25 July, these elections are of paramount importance for the country, they mark the end of a very difficult and challenging period and the beginning of a new stage for all citizens. The country cannot afford to fail on that.

Finally, I would like to reiterate the strong support of the OSCE for the sovereignty and territorial integrity of the former Yugoslav Republic of Macedonia and recall the continued efforts of the OSCE, together with other international partners, to assist in the fulfilment of the Framework Agreement. This is the only way to consolidate stability and build a more prosperous and democratic future for the former Yugoslav Republic of Macedonia and all its citizens.
