

EXECUTIVE SUMMARY

This guide is designed for practitioners working in the area of property rights, such as civil society organizations, notaries, cadastral offices and municipal bodies, where the interested parties can direct their questions and concerns regarding their property rights with the final objective to ensure that all have equal access to property and housing rights in Kosovo. The guide provides information on the main concepts related to property rights; it explains, step by step, the process of registration of a property that has been purchased, inherited or allocated based on a court decision. Finally, it contains a comprehensive directory of the main stakeholders at municipal level which ensure that an individual's access to property rights are respected.

Kosovo institutions have developed a relevant policy and legislation framework that is defined in the *Kosovo National Strategy on Property Rights*, the Constitution, the Law on Property and Other Real Rights, the Law on Inheritance, the Law on Family. As explained in Article 22 of the Constitution, the Universal Declaration on Human Rights, European Convention on Human Rights and Fundamental Freedoms and other international instruments are directly applied and provide comprehensive protection of property rights, including women's rights.

The right to property is one of the key human rights, therefore, protection and promotion of this right by Kosovo institutions is fundamental to confirm its commitment to the rule of law, good governance and compliance with the international and domestic mechanisms on human rights, including gender equality.

However, during its activities and field monitoring, the Organization for Security and Co-operation in Europe (OSCE) Mission in Kosovo found that particularly women, displaced persons and non-majority communities face challenges in free access and enjoyment of their property rights. Similar shortcomings were pointed out in the *Strategy*, which notes that due to patriarchal traditions and customary practices, some women continue to be denied of their property rights. Consequently, the current situation hampers women and non-majority communities' economic empowerment and social welfare.

To conclude, it is of utmost importance that Kosovo institutions as well as civil society increase their efforts, through rendering professional advice based on law and conducting awareness raising campaigns, to ensure that women and men from all communities can enjoy an equal access to property rights. The present publication is a step forward in that direction. Not only is it to support the practitioners, but also to provide relevant information to anyone who would like to learn about Kosovo and international legal framework in place, concrete steps to register a property and who to contact in these cases.

INTRODUCTION

The *Kosovo National Strategy on Property Rights* is the key policy document of the Government of Kosovo on property rights issues. It provides strategic vision on safeguarding property rights in Kosovo. According to the Strategy, "the lack of clarity in immovable property rights legislation, widespread informality in the property sector and inconsistent enforcement of rights has weakened the security of property rights in Kosovo. Insecure rights in property impacts human rights, disempowers marginalized communities and impedes economic growth". In this context, the Strategy recognizes the challenges faced by women, displaced persons (DPs) and members of non-majority communities to fully exercise their rights to property.²

Despite improvements in recent years, women own only around 17% of properties, only 15% of women business owners have used commercial bank loans and only 5% of women are licenced farmers in Kosovo.³ Women who do not own property and are not active on the labour market are in a vulnerable position. They are restrained from access to bank loans, opening their own business and, therefore, becoming economically independent. Economic dependency makes women more vulnerable to different forms of discrimination, especially to gender-based violence. Ownership and possession over land/property is one of a few mechanisms which can guarantee women their economic security and safety.

Therefore, access to property and enjoyment of property rights in Kosovo still continues to be a concerning issue. While generally the policy and legislation on property rights in place are fairly advanced in providing protection of these rights, this cannot be said for their implementation. Moreover, the social norms still continue to affect exclusion of women from property rights, despite the legal norms that provide such rights. Kosovo institutions, despite some positive developments, still lag behind when it comes to protection of property rights of vulnerable communities, especially those of specific groups of women.

This guide aims to inform civil society organizations and municipal bodies that provide services on property rights on resources and services available at the municipal-level where the interested parties can direct their questions and concerns regarding their property rights. A well informed civil society that is aware of the municipal services and bodies responsible for the implementation of applicable policy and legislation is the final goal in raising awareness on equal access to property and housing rights in Kosovo. Moreover, the guide explains the definition of the main concepts related to the property rights and a step-by-step approach to register a property that has been purchased, inherited or allocated based on a court decision.

The information on property rights issues affecting DPs, non-majority communities and women has been gathered through regular monitoring activities conducted by the OSCE since 1999, especially during the outreach information sessions organized for women in rural areas on their property rights in 2019.

The guide is structured in seven chapters. After the introduction, chapter 1 outlines relevant international standards, and policy and legislation applied in Kosovo to promote equal access to property rights. Chapter 2 describes the meaning of property and of the property rights. Chapter 3 elaborates on the types of property registration. Chapter 4 makes reference to inheritance rights. Chapter 5 speaks about informal settlements and unpermitted constructions. While Chapter 6 presents the stakeholders in the municipality. Chapter 7 informs on property registration. Lastly, in the conclusion, the

guide provides a number of suggestions and advice on how to improve property rights in Kosovo, with emphasis on women's rights. Finally, the guide ends with an extensive municipal directory that contains contacts to the main institutions and organizations working on property rights in each municipality.

CHAPTER 1: INTERNATIONAL STANDARDS, AND STANDARDS APPLIED IN KOSOVO TO PROMOTE EQUAL ACCESS TO PROPERTY RIGHTS

INTERNATIONAL LEGAL FRAMEWORK

Universal Declaration of Human Rights states that everyone has the right to own property alone as well as in association with others and that no one shall be arbitrarily deprived of his property.⁴

European Convention on Human Rights (Article 1 of Protocol 1) states that every natural or legal person is entitled to the peaceful enjoyment of his possessions. No one shall be deprived of his possessions except in the public interest and subject to the conditions provided for by law and by the general principles of international law.⁵

Convention on the Elimination of All Forms of Discrimination against Women (CEDAW) requires spouses to be entitled to the same rights in respect of the ownership, acquisition, management, administration, enjoyment and disposition of property, whether free of charge or for a valuable consideration. The document is directly applicable in Kosovo as per Article 22 of the Constitution.⁶

The Beijing Declaration and Platform for Action ensures women's equal access to economic resources, including land, credit science and technology, vocational training, information, communication and markets, as a means to further the advancement and empowerment of women and girls, including through the enhancement of their capacities to enjoy the benefits of equal access to these resources, inter alia, by means of international co-operation.⁷

Convention on the Rights of the Child, the International Convention on the Elimination of All Forms of Racial Discrimination, the Convention on the Rights of Persons with Disabilities and the International Convention on the Protection of the Rights of All Migrant Workers and Members of their Families also guarantee various rights related to access, use and control over land and other productive resources.⁸

LEGAL FRAMEWORK IN KOSOVO9

The Constitution stipulates that everyone is entitled to own property and that no one shall be arbitrarily deprived of property (Article 46).

Law No.03/L-154 on Property and other Real Rights governs the creation, content, transfer, protection, and termination of real rights and states that "any person can acquire real rights, unless otherwise provided by law". It also defines movable property, immovable property, ownership, co-ownership, and joint ownership, etc.

Kosovo National Strategy on Property Rights is a key policy document that aims to provide clarity in immovable property rights legislation, to address the widespread informality in the property sector and inconsistent enforcement of rights that have weakened the security of property rights in Kosovo. The successful implementation of the Strategy is expected to ensure security in property rights that would positively impact human rights, empower marginalized communities and stimulate economic growth.

The Law No. 04/L-174 on Spatial Planning provides sustainable governance, efficient use of public funds, preconditions for balanced economic development, sustainable space regulation, ensuring equal treatment, provision of free movement, and adequate access to public services for citizens (Art. 1, para. 2)

One of the aims of *Law No. 06/L- 024 Treatment of Constructions without Permit* is to create simplified procedures to enable legalization and to help citizens realize benefits from their constructions (Art.1, para.1, sub-para.1.2).

The aims of *Law No. 03/L-164 on Housing Financing Specific Programs* is to create sustainable housing for families or individuals that are in poor economic situation and cannot afford to rent or purchase a dwelling. The *Law prioritises* selection of beneficiaries coming from families of housekeeper-woman; divorced husband or wife that takes care for children and children with the status of orphan (Art. 11, para.1, sub-paras 1.1.3; 1.1.4 and 1.1.5).

The Law No. 2004/26 on Inheritance provides that all persons are equal to inherit under the same conditions. The Law provides that "children born out of wedlock, when fatherhood is known or verified by a court or competent body decision", as well as adopted children, are equal to other children. Where no will has been made or a will is invalid, the children and spouse of the deceased inherit first, in equal shares. Heirs may renounce their inheritance before a court or a notary, if not under coercion. A non-marital cohabiting couple (a woman and a man) may inherit from each other as spouses, if the relationship has lasted at least 10 years, or 5 years where they have children.

The Law No.2004/32 on Family contains a chapter on property relations of spouses. Property belonging to one spouse at the time of entering marriage remains separately owned. Property acquired through work during the course of the marriage is jointly owned. Even if joint marital property is registered under the name of one spouse, the property is still considered as jointly owned and as if it was registered in the name of both spouses. Consent of both spouses is required in the event of alienation of property. In Article 47, the Law provides that property acquired during marriage belongs to spouses equally, unless they have agreed differently (for instance, in a prenuptial agreement). Where the court evaluates each spouse's share of joint property, the decision is based on the contribution of each spouse, considering not only personal income, but also assistance that one spouse provided to the other spouse, including "children's care, conduct of housework, care and maintenance of property and any other form of work and co-operation pertaining to the administration, maintenance and increase of joint property" (Article 54).

The Administrative Instruction (GRK) No. 02/2020 on Amending and Supplementing Administrative Instruction (GRK) No. 03/2016 on Special Measures for Registration of Joint Immovable Property on Behalf of Both Spouses is an example of a gender sensitive legislation to stimulate the registration of joint immovable properties on behalf of both spouses in the public register. Its intention is to increase the number of women registered as joint owners and accelerate the

realization of equality between women and men in terms of ownership rights (positive discrimination). This normative act is binding for all institutions at all levels, other authorities and natural persons that perform public authorization related to the registration of immovable property on behalf of both spouses. In 2016, it was observed that only 105 cases were registered by couples. This number increased to 4,000 by the end of 2018.¹⁰

Law No.05/L-020 on Gender Equality (2015) provides the legal framework to ensure equal opportunities for men and women to participate in political, economic, social, cultural and other fields of social life in Kosovo. The Law also aims to create the conditions and opportunities for gender equality through policies that support overall development, especially for the improvement of women's status, so that they have equal access to opportunities.

The Kosovo Programme for Gender Equality 2020-2024 (the Programme) ¹¹ provides the policy framework to institutionalize access to and participation of both men and women in all aspects of life. However, the Programme also acknowledges that women do not currently enjoy their rights as men do and that three specific areas need to be addressed in order to work towards gender equality in Kosovo, namely the economic empowerment and social welfare, human development, roles and gender relations, and women's rights, access to justice and security.

Law No. 05/L-021 on the Protection from Discrimination (2015) is part of the legal framework for prevention and combating discrimination based on, *inter alia*, sex, gender, gender identity, sexual orientation, in order to implement the principle of equal treatment, also in regards to housing and other forms of property (Article 2, §1.9.). Its execution lays within the responsibilities of the Office for Good Governance in the Office of the Prime Minister, and Ombudsperson Institution.

CHAPTER 2: WHAT IS PROPERTY AND WHAT ARE PROPERTY RIGHTS?

Property includes, but is not limited to, physical goods or assets, but also a range of economic, tangible and intangible interests. The Law on Property and Other Real Rights in Kosovo¹² regulates types of property, which include:

- Moveable property, such as vehicles, or property that is not physically attached to the ground.
- Immoveable property, such as houses or apartments, the land itself or other property that is physically attached to the ground.

The right to property is a fundamental human right, recognized by a number of international human rights mechanisms (see page 5). However, the right to property may be subject to certain conditions or limitations. The legal framework in Kosovo guarantees the right to own property and states that law in accordance with public interest regulates the use of property. Furthermore, **no one can be arbitrarily deprived of property**, but the government may expropriate property if expropriation is authorized by law; necessary to achieve a public purpose or promote public interest; and those whose property has been expropriated receive immediate and adequate compensation.

Ownership is therefore very important for the enjoyment of property rights. Ownership refers to a set of rights that a property rights holder has, which includes: **right to possess the property, right to transfer the property ownership, right to be free from being interrupted in enjoying these rights**. In Kosovo, acquisition of property ownership is a two-step process, in addition to property *title*, registration of ownership in cadastral records is a legal requirement. Therefore,

process of **registering property** guarantees ownership rights¹³. Therefore, knowing how to register property is crucial for advancing women's property rights.

On another note, some owners of the property, including women, have been deprived from their property rights by illegal occupation, because of the conflict in Kosovo. In that case, the Kosovo Property Comparison and Verification Agency (formerly Kosovo Property Agency), has been the main institution to support individuals in reinstating access to their property.

CHAPTER 3: TYPES OF PROPERTY REGISTRATION

WHAT IS OWNERSHIP?

In Kosovo, **property ownership** refers to having the sole right to the property, possessing it, excluding others from any interference with the property and, independently deciding to sell or rent the property. In other words, not sharing the right to property with any other person. Women and men can register property as a sole owner when they individually purchase the property; when they inherit property, and when ownership has been transferred to them solely.¹⁴ The property that has been acquired during marriage is not sole property ownership and it is subject to equal division in case of divorce.

In Kosovo, **immoveable property and vehicles are required to be registered in the cadastral records.**¹⁵ Immoveable property is registered through a written request to the cadastral office of the municipality where the property is located. The municipal cadastral office will then confirm the time and date of receipt of the application for registration. The application for registration of a house or an apartment is to be submitted by the owner or someone with legal authorization to register the property on the owner's behalf.¹⁶

PROPERTY REGISTRATION - BEFORE, DURING AND AFTER MARRIAGE

There are different ways to register property jointly, depending on whether the property is co-owned with another individual or is jointly owned with a spouse. This section discusses the concept of joint or co-owned property and issues related to registering property during marriage, and the division of property following a divorce.

Co-ownership of property refers to sharing ownership over property with another individual or individuals. If the shares of ownership are not stated in advance, it is presumed that all owners have equal shares.

The co-owners are allowed to use the property in proportion to their share, and any assets accrued from the property are divided in proportion to their shares. A co-owner also has the right to dispose of their share of the property without the consent of the other owners. However, all owners must jointly administer the co-owned property.¹⁷

Co-ownership is different from joint marital property, which refers to the equal ownership rights of both spouses to most of the wealth accrued during a marriage, including property. Therefore, any property gained during marriage is considered the joint wealth of both parties, and, legally, registration of property shall be in the names of both spouses. Both spouses have equal shares in the property accrued during marriage. However, in Kosovo, joint marital property is often not registered in the names of both spouses. Since both spouses have equal shares of joint marital property, registration

should reflect this. Property ownership can help individuals to have collateral, which allow them to contract mortgages and loans, or start businesses. Therefore, it is significant that both spouses have equal access to opportunities that arise from being property owners, which can be much more difficult if the property is only in the name of one spouse. In this case, if the partner wants to be active in the economic sphere (get a loan, access to subsidies, start a business) this is impossible due to the fact that he/she do not own property.

Not all property is considered joint marital property. **Separate marital property** refers to property that belongs exclusively to one spouse or the other. This includes:

- Property acquired before the marriage.
- Inherited property or donated property.
- The share of the joint property that belongs to each spouse.
- Artwork and intellectual property.

In the case of **divorce** and dissolution of a marriage, both spouses are entitled to **equal shares** of their joint marital property. Given that property acquired during a marriage is considered joint marital property (other than those properties designated as separate marital property) regardless of whether or not it has been registered in both spouses' names, the property should be equally divided.

However, in order to ensure that this is adhered to as foreseen by the Law on Family¹⁸, **spouses should always ensure** that joint marital property is registered in the name of both spouses.

CHAPTER 4: WHAT ARE RIGHTS TO INHERITANCE? 19

Inheritance refers to the transfer of property from a deceased person (decedent) to their heirs (living descendants). When the deceased has not left a will for any or all of their property, or when the will is fully or partially invalid, inheritance is based on legal succession. Legal succession comes in question only in the absence of a will. There are three ranks of inheritance/legal succession:

- 1st rank: inheritance is transferred to the children and spouse of the deceased. The children and spouse shall inherit in equal shares.
- 2nd rank: inheritance is transferred to the spouse and parents of the deceased (when there are no children). The spouse and parents shall inherit in equal shares.
- 3rd rank: inheritance is only transferred to the spouse of the deceased (when there are no parents and siblings of the deceased). The spouse shall inherit fully.

While men and women have equal rights to inheritance according to the legal framework in Kosovo, patriarchal traditions and customary practices often have a negative impact on women enjoying equal inheritance rights. Due to family and social pressure, some women decide to waive their right to inherit. In other cases, the families decide not to include women heirs in the act of death.²⁰ All practitioners, particularly the notaries, should recognize that the ranks identified above apply equally to both men and women.

Children, spouses and parents are compulsory heirs.²¹ Grounds for exclusion from inheritance are limited and are outlined in the Law on Inheritance in Kosovo. Procedures for review of inheritance cases can be conducted through both Basic courts and notaries within each municipality.²²

CHAPTER 5: INFORMAL SETTLEMENTS AND UNPERMITED CONSTRUCTIONS

INFORMAL SETTLEMENTS

In Kosovo, informal settlements refer to housing with one or more of the following characteristics:

- Informal ownership of the property.
- Inadequate or deprivation of elementary services- such as proper running water, electricity or sewage systems.
- Inadequate participation in governance, including in decision-making process of interested parties (for example, during the development of the municipal spatial planning documents).
- High risk of structural failure of the building.

Some of the informal settlements can pose additional threats for women and girls, e.g. the lack of proper sanitation, hygiene and safe water access may have impact on sexual and reproductive rights of women and girls.

In Kosovo, all level of institutions are legally required to regularize informal settlements, which are identified within their municipal spatial planning documents. This can be done in one of three ways:

- Improving the condition of the settlements including infrastructure and services within the settlement.
- Destroying and re-building the settlement in line with adequate infrastructure and provision of services. This
 would involve relocating inhabitants for a set amount of time.
- Destroying and relocating the entire settlement and inhabitants to a new area. This action is proposed when a settlement is too close to a potentially dangerous zone- for example, when a settlement is too close to a municipal garbage dump or contaminated land.

An important component of regularizing informal settlements is prioritizing the services offered in order to make the settlement of adequate condition. Men and women may have different perspectives of what services should be prioritized, and what the needs and concerns are for the inhabitants in the settlement. One of the main concerns for women and girls is the access to safe reproductive health, physical safety, access to care facilities for children and elderly, etc. As it is the case with social housing, municipalities have a legal obligation to hold public consultation with all residents to determine municipal priorities in that regard. An outreach to under-represented groups is of crucial importance otherwise their voices and needs will not be part of the planning and their automatic exclusion will happen.

UNPERMITED CONSTRUCTIONS

Treatment of constructions without permit is another issue which may affect the rights of women and men. Namely, by mid-2016 the construction of buildings without permit Kosovo-wide amounted to around 350,000 constructions.²³ The relevant authorities have addressed the issue through promulgation of the Law on Treatment of Constructions without Permit²⁴. While the municipalities have the responsibility to implement the law, they should ensure that women's rights

are respected in the process, which also creates opportunity to advocate for registration of spouses' joint property ownership.

CHAPTER 6: WHO ARE THE STAKEHOLDERS IN THE MUNICIPALITY?

Municipal Human Rights Units (MHRUs) and Municipal Officers for Gender Equality (MOGEs)

MHRUs and MOGEs are mechanisms responsible for the promotion and protection of human rights at the municipal level and in accordance with the laws, policies and international standards [see p. 9 in reference to MOGEs].

Municipal Cadastral Officers (MCOs)

MCOs deal with registering privately owned immovable property and municipality owned immovable property. They also review and complete administrative procedures for the return of land to the owner, and identify and settle interim measures prior to courts decisions on land. MCOs are also responsible for registering mortgages, court imposed interim measures on disputed properties, and for maintaining, correction and harmonizing records of settlements, villages, streets and numbers of objects and buildings.

Non-Governmental Organizations (NGOs)

NGOs and women's rights specialized NGOs can play an important role in advocating and lobbying for the rights of women. The NGOs included within the list of resources in this document specifically work to foster gender equality and equal access to property and housing rights. This list is not exhaustive, but rather is based on OSCE field research.

Free Legal Aid

District Legal Aid Bureaus provide free legal aid to those who qualify. They can facilitate women's access to property rights, by providing paralegal and legal information and advice for women who are unaware of their rights in this regard, and by representing women in court or administrative bodies and by assisting with drafting of legal submissions and procedures.

Ombudsperson Institution (OI)

The OI is an independent institution mandated to address alleged human rights violation by public institutions in Kosovo. The OI conducts investigations, issues reports and provides legal services and public advocacy. The OI provides services free of charge and accepts complaints from anyone in Kosovo. The OI offices are located in Prishtinë/Priština, Pejë/Peć, Prizren, Gjakovë/Đakovica, Mitrovicë/Mitrovica South, Mitrovica/Mitrovicë North, Gračanica/Graçanicë, Gjilan/Gnjilane and Ferizaj/Uroševac.

Notary


Notary service is a public service that aims to protect legal interests of natural and legal persons. Notary is a professional lawyer, public official, appointed by the Ministry of Justice, who are independent and unbiased in exercising the notary services. The notary functions are: compilation and verification of contracts, notarization of statements, certification of signatures, and reviewing non-contested inheritance cases and other duties as provided in the Law on Notary, from which the mandate and functions of notaries derive.²⁵

CHAPTER 7: HOW TO REGISTER A PROPERTY?26

HOW TO REGISTER A PROPERTY THAT HAS BEEN PURCHASED?

Registration of the property title in the immovable property rights registry, in Municipal Cadastral Office, is a precondition to acquire property right over the immovable property (after you have concluded a sales contract, received a decision from court or administrative bodies, or other relevant document foreseen by the Law No. 2002/5, as amended and supplemented by Law No. 04/L-009 Article 3, para. 3.7).



REQUIRED DOCUMENTS AT THE NOTARY OFFICE:

- Copy of your Kosovo ID card and of the seller, and your spouse.
- Proof of payment of the purchase price (bank invoice or personal receipt).
- ✓ Certificate of ownership of the seller, which is issued by the Municipal Cadastral Office (MCO) with a payment of €4 fee.
- ✓ In case the property has to be divided, a copy of the property plan, issued by the MCO geodesy sector for a fee of €5.


REQUIRED DOCUMENTS AT MUNICIPAL CADASTRAL OFFICE

- ✓ Completed registration application form.
- ✓ A copy of the notarized sales contract.
- ✓ All documents provided to the notary.
- ✓ Proof of payment of the immovable property tax (from the Municipal Finance Office).
- Proof of payment of the registration fee (payment depends on the value of the property from €30 to €500). If the property is registered as marital (joint) property between husband and wife, there is no registration fee. Any payment of the fee or tax over €10 must be made at the bank and proof of bank payment is required. Payments under €10 are paid at the relevant office.

HOW TO REGISTER A PROPERTY THAT HAS BEEN INHERITED?

When an adult dies, the deceased's property should be distributed to that person's heirs through a formal inheritance procedure. The spouse and children (daughters and sons) have the right to inherit the property as first-rank heirs. In their absence, the Law on Inheritance regulates the order of inheritance. If all the heirs agree on how to divide the property between them, then the inheritance procedure is an uncontested procedure that can be initiated in court or at the notary. If the heirs do not agree on the division of property, then they must go to court to initiate the contentious inheritance procedure. Heirs should ask the court or notary about the fees to be paid in connection with this procedure.

Remember: The death evidence needs to contain complete information about all the movable and immovable property of the deceased and the list of all heirs (male and female).



- Proof of payment of the registration fee (if the heirs have a notarial decision, the fee is €10 per heir. If the heirs have a court decision, the fee is €50).
- Any payment of the fee or tax over €10 must be made at the bank and proof of bank payment is required. All payments under €10 are paid at the relevant office.

- The MCO can provide the list of surveyors and surveying companies as well as the surveying fees. The heirs must sign the contract at the notary office where the details of the division of property are given.
- Within 60 days from the realization of the geodetic measurements, each heir must submit the request to the MCO for the registration of the divided property.
- The heir must attach the notarized contract and pay the fee of €20.

HOW TO REGISTER PROPERTY RIGHTS BASED ON A COURT DECISION?

When the court rules on a property rights dispute, it issues a decision confirming ownership rights over that immovable property. If you are the person whose property rights have been established by the court decision, the following process applies.



HOW TO REGISTER PROPERTY RECEIVED AS A GIFT?

A person can also become the owner of a property through receiving it as a gift. To start the process of registration of property received as a gift in the Municipal Cadastral Office, a contract is required between the donor and the recipient, concluded officially by the notary in the presence of the donor and the recipient at the notary office. The notary compiles the notarial deed/contract that contains specific information about the property in question. The notary informs the donor and the recipient on the obligations they assume with the execution of the contract. The contract stipulates that the recipient agrees to accept the gift.

The notary fee for a gift from a parent to a child is 50% of the fee that applies in case of sale of the property, a fee which is based on the value of the property. If the property being donated is to be separated from a larger property, the donor must hire a licensed geodesy surveyor or surveying company to conduct the separation of the property.

The owner of an immovable property (donor) can transfer the right over his/her property or a part of his/her property to the recipient free of charge. The recipient may be his/her potential legal heirs or a third/external party. The recipient(s) must agree or disagree on such a donation. Property subject to this transfer may not be part of a subsequent inheritance process after the death of the owner (unless this transfer impedes the realization of the inheritance right of one or more legal heirs). The relationship between the donor and the recipient is defined in the Law on Obligations and partly in the Law on Inheritance.

The documents that have to be presented to the MCO in that case entail: completed application registration form (Annex 3); The gift contract, drafted and certified by a notary; Your copy of the ID card; Proof of payment of immovable property tax (from the Municipal Property Tax Office); Proof of payment of the registration fee (different fees apply, MCO will inform on the correct fee applied in each specific case). As in other cases, the MCO issues the ownership certificate within 15 days.

CONCLUSIONS

Kosovo has a well-developed policy and legal framework on the access to property rights. However, there are a few remaining challenges, confirmed also in the *Kosovo National Strategy on Property Rights* that refer to insufficient enforcement of these laws, particularly for women, displaced persons and non-majority communities. It is under this premise that the present guide has been drafted, contributing to better implementation of the existing laws and regulations.

The awareness of one's property rights, which includes, *inter alia*, the knowledge of administrative requirements, legal processes and the main stakeholders, varies according to gender, age, community and place of residence (urban vs. rural). While the main legislative documents are usually widely available, non-Albanian communities are basically deprived from access to practical information on how to register a property; none of the informative brochures on property registration nor the template of the property registration form (available on the Cadastral Agency's website) are available in languages spoken by most non-majority communities. Moreover, outreach and awareness raising campaigns in the rural areas are of crucial importance.

Consequently, the relevant institutions and civil society should increase their efforts in raising awareness on the access and protection of the property rights of women, displaced persons and non-majority communities so they can fully exercise in practice their rights to property. That includes delivering an informed advice to all individuals that want and/or need to be informed about their property rights. None of these initiatives should be hampered by the traditional social norms nor by a restricted access to information.
