CIRCULAR NOTE NO. 6

ON NON-GOVERNMENTAL ORGANISATIONS' ACCREDITATION AND FOLLOWING OF THE 19TH OSCE MINISTERIAL COUNCIL MEETING

1. VENUE

The 19th Meeting of the OSCE Ministerial Council will be held at the Royal Dublin Society (RDS) Simmonscourt Complex, located at Simmonscourt Road, Dublin, on 6-7 December 2012.

Representatives of NGOs will be able to follow the proceedings of the Ministerial Council meeting according to the provisions of the Rules of procedure of the OSCE (MC.DOC/1/06 of 1 November 2006) part IV., IV.2 (B) paragraph 6: "Only the opening and closing sessions shall be open to the press and the public, unless the meeting decides to make the other sessions open. Unless otherwise decided, all sessions, except for those taking up agenda items which are subject to discussion and possible decision shall be broadcast live in all working languages to the media centre and NGO centre by closed-circuit television."

The live broadcast through closed-circuit television will be provided at the RDS media centre.

2. FACILITIES FOR NGOS

Representatives of NGOs will have full use of the media centre at the RDS. There will be dedicated IT facilities, including a high-capacity wireless connection. A meeting room will also be made available for use by representatives of NGOs.

3. REGISTRATION AND ACCREDITATION OF NGOs FOR THE MINISTERIAL COUNCIL MEETING

The entire RDS venue will be a secure area, permitting access only with an accreditation badge. Advance registration is mandatory and will take place via a dedicated online registration system at https://delegation.osceministerial2012.ie/php/self/login.php

The deadline for registration is close of business on Friday 16 November.

When you visit the above weblink, please proceed as follows:

- On your first visit, please click "Create new account" to register your e-mail address.
- You will then receive an e-mail providing a password.
- When logging-in to the registration site, please insert your e-mail address into the "Enter Username" field. For "Password", please use the password provided in the e-mail received.
- You will also be required to input a unique verification code in the field marked "Delegation Code". **The code for NGOs is OSCEMC.NGOrg** (Please note that the code is case sensitive).
- After login, you may change your password by clicking on the "Password" icon on the top right-hand corner.
- If you have any technical enquiries, please e-mail <u>OSCEadmin@dfa.ie</u> or click on "help" on the top right-hand side of the registration site.

A colour photograph of each NGO representative should be submitted in .jpg format as part of the online registration process. All personal data sent to the Department of Foreign Affairs and Trade will be treated in accordance with the highest security and national and international data protection standards.

Confirmation of successful accreditation will be sent by e-mail after the deadline for registration (16 November). Details regarding collection of accreditation badges will also be sent at that time.

4. HOTEL RESERVATIONS

Arrangements have been made for accommodation of representatives of NGOs in the Burlington Hotel in Dublin, which is in the security and transport zone for the OSCE Ministerial. Reservations must be made via the following link, operated by Conference Partners:

5. TRANSPORT

A free shuttle service will operate between the Burlington Hotel and the RDS on 6 and 7 December.

6. VISAS

Nationals of the following countries require a visa for entry to Ireland:

Afghanistan, Albania, Algeria, Armenia, Azerbaijan, Belarus, Bosnia and Herzegovina, Egypt, the former Yugoslav Republic of Macedonia, Georgia, Jordan, Kazakhstan, Kyrgyzstan, Moldova, Mongolia, Montenegro, Morocco, Russian Federation, Serbia, Tajikistan, Thailand, Turkey, Tunisia, Turkmenistan, Ukraine and Uzbekistan.

Visa-required delegates should note that Ireland is <u>not</u> in the Schengen zone, so a Schengen visa is not sufficient to enter Ireland.

Visa applicants are encouraged to submit their applications in order to ensure the timely processing of all visas – **an application can take up to four weeks to process**. The visa fee will be waived. However, applicants will be responsible for courier charges where applicable.

Submitting a Visa Application

Visa applications should first be made on-line at:

https://www.visas.inis.gov.ie/avats/OnlineHome.aspx

When processing the registration for the visa application

- a) select the link "Short Stay"
- b) and after that, when replying to "What is the reason for travel", select: conference.

Applicants are reminded that completing the on-line application form is only the first step in the visa application process. An application can only be processed when the on-line form is completed AND the required backing documentation and passport photograph are received by the relevant office as indicated by the on-line system. This will usually be the Irish Embassy or Consulate in, or accredited to, the country in which you normally reside.

For attendance at OSCE events in Ireland, special arrangements have been put in place to process visa applications. If you are directed by the online system to forward your application to Dublin, please disregard this request and send your documentation to your nearest Irish Embassy or Consulate, or the Irish Embassy in Vienna, which is authorised to process your application in a timely manner.

The following information should be sent to the Embassy listed below by visa-required applicants:

- Passport, valid for six months after your scheduled departure date
- Printed and signed copy of the summary of the online visa registration;
- A printout of this note;
- Two passport photos;

- One letter from the applicant's employer which confirms the following:
 - Attendance at the conference;
 - Evidence of who will be responsible for all costs including travel, accommodation and expenses;
 - Evidence of the applicant's date of expected return.
